Over the last 15 years, Mr. Chang has conducted numerous training courses and delivered many papers on topics relating to chemical metrology such as method validation and measurement uncertainty. In addition, he is also a qualified lead assessor for ISO 17025 laboratory accreditation scheme since 1997. He was a member of the National Measurement Council from 2008-2011, the chairman of SIRIM ISC B, Technical Committee on General Purpose Chemicals 2005 – 2011 for development of national standards. Since 2011, he represents IKM serving as a member of the Malaysia Accreditation Council (MyNAC) and Malaysia Standard Council (MyNSC).
